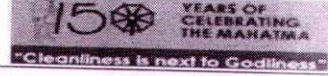

OFFICE ORDER

Sub: Consolidated Revised Guidelines on the measures to be taken by Ministries / Departments of Government of India, State / UT Government and State / UT authorities for containment of COVID-19 in the country – FOR THE CSTRI SUB-UNITS ONLY- Regarding.

In continuation to this Office letter No. CSB/ CSTRI/ BNG/ Estt-Imp-A/2019-20 Dated: 20.05.2020 (available on website) , all the Scientists / Officers and staff of CSTRI Sub-units are hereby advised to note that the Ministry of Home Affairs, Govt. Of India, has issued revised guidelines vide No.MHA OM NO. 40/3/2020 DM - I (A) dated 30/5/2020 (Attached) for necessary compliance. The period of lockdown has been extended up to 30/06/2020 only in containment zones with certain relaxations. Further, they are advised to refer to the C.O letter vide No. CSB-63(1)/2020-ES .I dated 31st May 2020 (Available in www.cstri.res.in and www.csb.gov.in).The classifications of zones shall be decided by the respective State governments as per the Ministry of Home affairs, Govt. of India, New Delhi vide MHA OM NO. 40/3/2020 DM - I (A) dated 30/5/2020 addressed to All the Chief Secretaries (Attached). The respective offices shall obtain the list of containment zones from District Authorities. Officials who are having adverse conditions can avail of guidelines in DoPT OM dated 19th May 2020 (available www.csb.gov.in).The duty roster for Officers and staff as advised by DoPT OM dated 18th May 2020 (already available in www.cstri.res.in and www.csb.gov.in) may be continued until revised guidelines are issued in this regard.

All Group-A Officers from the level of Deputy Secretary/ Joint Director/ Scientist-D and higher drawing functional pay in the Level of 12 and beyond, shall attend office in full strength. Scientists / Officers and staff who are residing nearby Office premises should make attempt to attend office if their name is not drafted for the duty. Those Officers / staff who are not required to attend office on a particular day shall work from home should be available on telephone , electronic means of communications at all times and if required report for the duty in exigencies except in cases of quarantine or areas in containment zones.

This is for necessary compliance by all CSTRI sub units.



Sub: Consolidated Revised Guidelines on the measures to be taken by Ministries / Departments of Government of India, State / UT Governments and State / UT authorities for containment of COVID-19 in the country - Regarding.

In continuation of Office Order in reference dated 18th May, 2020 (available on website), the Ministry of Home Affairs, Govt. of India has issued revised guidelines vide MHA O.M. No. 40-3/2020-DM-I(A) dated 30th May, 2020 (attached) for necessary compliance by all Institutes and Offices of Central Silk Board. The period of Lockdown has been extended upto 30.06.2020 only in Containment Zones with certain relaxations. The classification of Zones shall be decided by the respective State Government as per Ministry of Home Affairs, Govt. of India, New Delhi vide OM No. 40-3/2020-DM-I(A) dated 30th May, 2020 addressed to all Chief Secretaries (attached). The restriction on number of staff attending office has been removed except those Officials who fall under 'Containment Zones' or under 'Quarantine'. The respective offices shall obtain the list of 'Containment Zones' from the District Authorities. Officials who are having adverse Medical Conditions can avail of guidelines in DoPT O.M. dt 19.5.2020 (attached). The Duty roster as advised by DoPT OM dt 18th May, 2020 may be continued until revised guidelines are issued in this regard.
